## FAITH & FINANCES

In an effort to address what we believe are FOUNDATIONAL ISSUES for a community living in poverty, I will be more focused in the coming months creating Life Application Groups around the topics of marriage, parenting, and personal management of finances.

Toward that end, I (Scott) was recently trained to be a facilitator for the 12-week **Faith & Finances** curriculum. If you are familiar with the book "When Helping Hurts", you will recognize the name Chalmers Center ([www.chalmers.org](http://www.chalmers.org)). These are the same folks who produced the Faith & Finances study.

In addition to being based on *Biblical principles* of financial management, one of the things I am most excited about (and what sets it apart from some of the more popular faith-based materials) is that it is *specifically designed and focused for low-income people*.

Two other significant features include the *emphasis of the local church's participation and leadership*, as well as the vital role **Allies (mentors)** play in **ongoing relationship-building** that includes a one-year commitment to regularly encourage, hold accountable, communicate with, and pray for (and with) the

I am also in conversation with churches, shelters, and low-income apartment complexes about teaching the material in their contexts. When we have good support in place, we will begin the launching of the course.
